RADA Trelawny- Agro-Processing Facility and Kitchen Construction (#73220)

The Jamaica Social Investment Fund now invites sealed bids from eligible and qualified bidders for the RADA Trelawny– Agro-Processing Facility and Kitchen Construction. The scope of works involves but is not limited to the construction of an agro processing measuring approx. 135 sq. meters to include: Reinforced 6 "block walls, Male and female restrooms with disable access, Building will be equipped with smoke detectors and fire extinguishers, Installation of Aluminum Windows and grilles, Industrial propane tank on concrete base and Installation of 1#-1000 gallon rhino tank for water storage. Construction period is Four (4) months.

The scope of works involves but is not limited to the construction of an agro processing measuring approx. 135 sq. meters to include: Reinforced 6 "block walls, Male and female restrooms with disable access. Building will be equipped with smoke detectors and fire extinguishers, Installation of Aluminum Windows and grilles, Industrial propane tank on concrete base and Installation of 1#-1000 gallon rhino tank for water storage. *Construction period is Four (4) months*.

All national Bidders must be tax compliant at bid opening and a valid **Tax Compliance Certificate** (TCC) and proof of registration with the **National Contracts Commission** (NCC) in the category "**Building Construction**" **Grade 3 and above** and must be submitted with their bid at the time of bid opening. Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the World Bank's Guidelines: Procurement under IBRD Loans and IDA Credits, and is opened to all bidders from Eligible Source Countries as defined in the guidelines and the Government of Jamaica Handbook of Public Sector Procurement Procedures (Revised March 2014), Volume 2 of 4 Procedures for the Procurement of Goods, General Services & Works
