TENDER FOR THE SUPPLY AND DELIVERY OF SCHOOL FURNITURE USING FRAMEWORK CONTRACT

1. The Government of Jamaica has received financing from various International Donor Entities toward the cost of the Jamaica Social Investment Fund (JSIF). The Jamaica Social Investment Fund intends to apply a portion of the proceeds of these financing to eligible payments under the contract for the *Supply and Delivery of School Furniture using Framework Contract for one (1) year* as listed below.

2. The JSIF now invites sealed bids from eligible *Suppliers of School Furniture*.
3. Bidding will be conducted through the *Local Competitive Bidding (LCB)* procedures specified in the Government of Jamaica Handbook of Public Sector Procurement Procedures (Revised March 2014), volume 2 of 4 procedures for the Procurement of Goods, General Services & Works.
4. All national Bidders must be tax compliant at bid opening and the time of Call-off orders and a valid **Tax Compliance Certificate (TCC)** and proof of registration with the **National Contracts Commission (NCC)** in the categories '*School Furniture*' AND/OR '*Furniture supplies*' must be submitted with their bid at the time of bid opening and Call-off orders. Interested eligible bidders may obtain further information and inspect the bidding document at the Jamaica Social Investment Fund at the address below from **8:30 a.m. to 4:45 p.m.** during the Bid collection period **Tuesday, September 1, 2015 to Tuesday, September 15, 2015**. A complete set of bidding documents in English may be purchased by interested bidders on the submission of a written Application to the address below and upon payment of a non-refundable fee of **Two Thousand, Five Hundred Jamaican Dollars (J\$2, 500.00)** for printed copy or **Five Hundred Jamaican Dollars (J\$500.00)** for Compact Disc (CD) in cash or certified cheque made payable to the Jamaica Social Investment Fund. **All bids must be submitted in printed copy.**

6. Bids must be delivered to the address below by **12:00 noon on Wednesday, September 16, 2015**. Bids will be opened in the presence of bidders' representatives who choose to attend at the address below on **Wednesday, September 16, 2015 at 12:05pm**.
7. Late bids, electronic bids, bids not received, bids not opened and not read out in public at the bid opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
